## MA130 COURSE GUIDELINES

1. You will note that this course uses MyStatLab for homework, exams and access to lectures. MyStatLab access comes with the bundle sold by the bookstore for the course. If you purchase the text separately, MyStatLab **does not** come with the text. You must login to MyStatLab immediately. Instructions come with the access you purchased. You can also purchase the access separately at the website. Lectures and handouts for the week can be found in the announcements after you login.
2. You will have homework, four exams, and a final. Getting signed up in MyStatLab and Examity before midnight, Saturday 9/01 is 5% of the grade. The homework will be worth 20% of the grade, exams 50%, and final 25% of the grade. To receive full credit on the homework, assignments must be completed by the due date. There is a 20% penalty for late submissions. There is 0% credit if not completed by the final exam.

### COURSE OBJECTIVES

- A. To introduce students to elementary probability and its applications;
- B. To introduce students to some basic methods of statistical analysis;
- C. To provide enough statistical training so that students can read research articles, communicate with statisticians, and interpret computer outputs involving means, standard errors, significance levels, confidence limits and other fundamental measures.
- D. To introduce students to a statistical computing package (Minitab) and use this package to solve problems in probability and statistics.
